This letter is to advise you of the action of the Accreditation Council for Education in Nutrition and Dietetics (ACEND®) Board regarding the **Dietetic Internship at The University of Tennessee-Knoxville**. During its July 25-27, 2018 meeting, the ACEND Board voted to continue full accreditation of your program for a term of seven years ending **December 31, 2025**. Accreditation is granted for a graduate degree Dietetic Internship enrolling 12 full-time interns annually with Community Nutrition concentration.

The decision was based on a peer review of your self-study report addressing the 2017 Accreditation Standards, site visit report and your program's response. ACEND recognizes your program's compliance with the 2017 Accreditation Standards and encourages you to continue your efforts in providing quality dietetics education.


The next accreditation review of your program by the ACEND Board will be in **2025**. You will receive correspondence at least one year in advance of the site visit, which will be scheduled in **September to December 2024**, inviting you to apply for full accreditation under the Accreditation Standards in effect at that time.

If you wish to propose a major change to the program, you must submit it in writing to ACEND for review prior to implementation. The ACEND Board maintains the right to require an interim report, self-study report, and/or site visit as a result of any changes.
