On behalf of the Committee on Accreditation (COA/the Committee) of the American Library Association (ALA), I write to inform you that the Committee voted to grant Continued accreditation status to the program leading to the degree of Master of Science in Information Sciences at the University of Tennessee.

The next comprehensive review visit is scheduled for spring 2023 unless the COA is persuaded to take other action in the interim.

This decision was made at the Committee meeting on June 26, 2016, with the "totality of the accomplishment and the environment for learning...rather than from a consideration of the isolated particulars" (Standards, Introduction) in mind, and was based on the Program Presentation; the External Review Panel Report; the program's response to the ERP Report; all of the reports the program submitted to the Committee since the last comprehensive review; and the June 26, 2016, meeting with Eileen Abels, Chair of the of the External Review Panel; and the meeting following that with you, Robert Hinde, and Eileen Abels.

From this point forward, all reporting must address the revised *Standards for Accreditation* adopted by ALA Council on February 2, 2015. • V.6. Provide an update on any developments regarding the operating budgeting model for the program.
