Because the general impressions of different site teams are inherently noncomparable, the Accreditation Committee does not attempt to summarize all the information that could be gleaned from a site evaluation report, and recipients of this letter are encouraged, therefore, to consult the full site evaluation report for collegial advice and general impressions of the team. - (74) For the 2011-12 fiscal year, the Law School generated \$9,256,110 in tuition and fees; its total expenditures were \$15,965,753. Additional revenue for the Law School came principally from University support (\$3,525,374) and endowment income (\$1,115,201). Since the last site visit, the Law School's endowment has increased from approximately \$10 million to \$17 million.
- (75) The Law School has and anticipates adequate financial resources to sustain a sound program of legal education and to accomplish its mission.

#### **CONCLUSIONS:**

- (1) The Accreditation Committee concludes that it currently has insufficient information to make a determination as to the Law School's compliance with the Standards in the following respects:
  - (a) Standard 212(b) and Interpretation 212-3, with regard to the requirement that the Law School demonstrate by concrete action its commitment to having a faculty that is diverse with respect to gender, race, and ethnicity, in that it is unclear what actions the Law School has taken to increase the diversity of its adjunct faculty. [See Finding of Fact (35).]
  - (b) Standard 302(a)(3) and Interpretation 302-1, in that the record is unclear regarding the nature of the required faculty supervision for the Expository Writing requirement. [See Finding of Fact (8).]
  - (c) Standard 504(a), in that it is not clear that the Law School advises applicants that there are character, fitness, and other qualifications for admission to the bar, and to encourage applicants, prior to matriculation, to determine what the requirements are in the state or states in which the applicant intends to practice. [See Finding of Fact (48).]
  - (d) Standard 505, in that it is not clear that the Law School includes, for every readmission of a previously disqualified individual, a statement in the admittee's file of the reasons that led to the decision. [See Finding of Fact (49).]
  - (e) Standard 701 and Interpretation 701-2(3), in that it is not clear that there is sufficient office space for part-time faculty members adequate for faculty-student conferences. [See Findings of Fact (26) and (72).]
- (2) Based on its review of the site evaluation report, the Committee encourages the President and Dean to consider carefully the following issue relating to the Law School:

The listing on the Law School's website of courses that have not been offered during the past two academic years and are not being offered in the current academic year. A law school that lists a significant number of such courses is not in compliance with Standard 509(b)(5) and Interpretation 509-1. [See Finding of Fact (53).]

Although this matter does not require a response from the University and Law School, it nonetheless merits close attention and review.

Cora and Michael -

Attached is the letter from the ABA regarding the LL.M. (Master of Law). They "acquiesce" to the College of Law's addition of the LL.M. program. On the last page under the heading Conclusions, items 3 and 4 seem to indicate that the degree is not an accredited program. Basically, they approved that the College of Law added the program with the proviso that having it doesn't detract from the JD, which is accredited. The program is available for the first time fall semester 2016.

I have not reported this degree to SACS COC as a substantive change because it is not a significant departure from programs we already have. We are approved to offer Master degrees; no new faculty, library or physical resources are needed; and less the 25% of the credit hours needed for the degree were added to the catalog.

## DECISION OF THE ACCREDITATION COMMITTEE June 2015

The Accreditation Committee (the "Committee") at its June 25-27, 2015 meeting, considered the application of the University of Tennessee College of Law (the "Law School") for acquiescence in the establishment of a new Master of Law in United States Business Law. The Committee had before it the Law School's Major Change-Post J.D./Non J.D. Degree Programs in Addition to J.D. Questionnaire, dated April 20, 2015; the Law School's most recent Self Study prepared in 2012; a letter dated April 20, 2015, from Chancellor Jimmy G. Cheek and Dean Douglas Blaze; and the minutes of the Law School faculty meeting of January 29, 2014.

#### **FINDINGS OF FACT:**

- (1) The Law School has proposed to offer a Master of Law (LL.M.) in United States Business Law. The program would begin in the fall 2016 semester.
- (2) The Law School reports that its anticipated enrollment in the new Master of Law program in the first year of the proposed program will be three full-time students with an eventual enrollment of "around ten" students in four years. The Law School has an enrollment of 442 J.D. students.
- (3) Students in the Master of Law in United States Business Law will be permitted to enroll in courses offered in the J.D. program. Students in the LL.M. program will have priority in course registration over students in the J.D. program. In general, the Law School does not believe that J.D. students will be excluded from any courses based upon current enrollments for classes of interest to the LL.M. students. The Law School anticipates that there might be two courses that can reach maximum enrollment, however, and is prepared to offer multiple sections to insure that J.D. students will be able to take the courses.
  - (4) The Law School has a proposed curriculum for the degree.
- (5) The Law School will require TOEFL scores of at least 570 (paper-based exam), 30 (computer-based exam) or 88 (Internet-based exam).
- (6) The Law School does not anticipate that any additional faculty, library resources, classroom space, or offices will be necessary to operate the program. The Law School will add a one-third time staff position to support the program.
- (7) The program will be directed by Professor George Kuney, a full-time member of the faculty.
- (8) The Law School anticipates additional expenditures of \$27,100 for the first year of the new program and \$27,342 in the second year.

- (9) The Law School anticipates income from tuition and fees of \$37,752 per student the first year and \$39,214 per student the second year.
- (10) The Law School faculty approved the proposal for the LL.M. program at its meeting on January 29, 2014.

### **CONCLUSIONS:**

- (1) The Committee concludes that the Master of Law in United States

  Business Law will not interfere with the ability of the Law School to operate in
  compliance with the Standards and to carry out its program of legal education.

  [Standard 313.]
- (2) Accordingly, under authority delegated by the Council of the Section of Legal Education and Admissions to the Bar, the Committee acquiesces in the application of the Law School for the establishment of the Master of Law in United States Business Law to a maximum enrollment of 12 full-time students. [Standard 506.]
- (3) Acquiescence in a degree program other than the J.D. is not an approval of the Master of Law (LL.M.) in United States Business Law program itself and, therefore, the Law School may not announce that the program is approved by the Council. [Standard 313 and Interpretation 313-1.]
- (4) The Committee calls the attention of the Law School to the requirement that enrollment in this and every non-J.D. program offered by the Law School must be limited such that enrollment does not interfere with the ability of the Law School to operate in compliance with the Standards.
